RULE 17 (a) of the Kerala Cinemas (Regulations) Rules, 1958.

Rule 17 (a) For every licence, when granted or renewed, a fee shall be charged according to scale laid down below:

(1) For an annual licence.

Rs ten for an area of 1000 sq ft. or less with an additional fee of rupees 5 for every 500 sq. ft. or fraction thereof in excess of 1000 sq. ft.

- (2) For a temporary licence for a period not exceeding three months for abuilding thatched or constructed of wood or mats or other inflammable materials or for a tent. Rupees 15 for a period of three months or for a portion thereof for an area of 1000 sq. ft. or less with an additional fee of Rs. 71/2 for every 500 sq. ft. or fraction thereof in excess of 1000 sq. ft.
- (3) For a temporary licence for a period not exceeding three months, for a building not thatched or constructed of inflammable materials-Rupees 2 for a month or for portion thereof for an area of 1000 sq ft. or less with an additional fee of Rupee 1 for a month or a portion thereof for every 500 sq. ft or fraction thereof in excess of 1000 sq. ft.
- (4) The fees for temporary licence shall be leviable at half the have rates where the building or enclosures are used solely by day and without lights.

Explanation:

Where the place consists partly of a structure and partly of a mere unroofed enclosure the fee shall be calculated on the area of the structure alone.

(5) Duplicate of a licence may be granted on payment of a fee of Rs. 10-only.
